## **Mid-Year Market Update**

Just three months ago, investors were worried about the end of the longest economic expansion on record after major U.S. stock indexes lost about 35% of their value in less than six weeks. U.S. stocks recovered with their best quarter in percentage terms in more than 20 years. This was partly due to the major stimulus by the Federal Reserve and Congress and hopes that the economy

can pull out of its severe, sudden recession relatively quickly. As governments relaxed lockdown orders meant to slow the spread of the coronavirus, there has been improvement in the job market and in retail sales. The rally has slowed lately as a resurgence in cases has raised concerns about how soon the economy will bounce back. The sharp recovery in stock indexes during the second quarter again underscores the importance of staying fully invested in an appropriate asset allocation. (1)
